#### 03.23.07 Communication

## 03.23.08 Reports from District and County Councillors

OCC updates:

- OCC has increased council tax by 5%
- 20mph signs are now installed in Bucknell
- Bucknell will be provided with a tree as part of OCC's planting scheme. It will be a flowering cherry tree with no financial implication to the parish council. The planting site has been identified.

#### CDC updates:

- The Local Plan consultation has been deferred. It will be re-presented after scrutiny. There will be a 2nd consultation which will include engagement with parishes.
- Fees for the brown bin collection are entering the 2<sup>nd</sup> year and is now aligned with changes in neighbouring districts and has shown an increase in re-cycling.
- The CDC council tax increase has been through scrutiny,
- The books are balanced and no services have been cut
- There have been a huge number of objections to Hawkwell. Developers are lobbying CDC
- Funding is available for Coronation celebrations

Parish councillors questioned councillors on a variety of topics including lack of transparency of processes, views on Ardley Rail Freight proposal, Warehouseing proposals, Roads, Waste collections.

The outcome was that Cllr Wood pledged to provide a copy of the CDC Executive Forward Plan to the PC once a month
